**Appointment - Acting Director of Administration – Steven Overbay**

1           **WHEREAS**, pursuant to Chapter C, Article 4, Section 413 of the Cecil County Charter, Temporary  
2 Administrative Appointments; and

3           **WHEREAS**, in accordance with Section 413 of the Cecil County Charter, when a vacancy occurs  
4 in the position of Director of Administration, the Executive shall appoint an acting Director of  
5 Administration to serve for a period not to exceed six months; however, this limit may be extended by  
6 the Council for a period of time not to exceed an additional four months; and

7           **WHEREAS**, in accordance with Section 413 of the Cecil County Charter, the County Executive  
8 appointed Steven Overbay as Acting Director of Administration; and


9           **WHEREAS**, the County Executive respectfully requests the approval for an extension of Steven  
10 Overbay as Acting Director of Administration for an additional period of four months.

11           **NOW THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
12 **MARYLAND**, confirms the recommendation by the County Executive of Steven Overbay for an  
13 extension of four months as Acting Director of Administration, which will expire on September 3, 2022.

14           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage  
15 by the County Council of Cecil County, Maryland.
