**Appointment - Acting Economic Development Director– Sandra Edwards**

1           **WHEREAS**, pursuant to Chapter C, Article 4, Section 413 of the Cecil County Charter, Temporary  
2 Administrative Appointments; and

3           **WHEREAS**, in accordance with Section 413 of the Cecil County Charter, when a vacancy occurs  
4 in the position of Director of Administration, the Executive shall appoint an acting Director of  
5 Administration to serve for a period not to exceed six months; however, this limit may be extended by  
6 the Council for a period of time not to exceed an additional four months; and

7           **WHEREAS**, in accordance with Section 413 of the Cecil County Charter, the County Executive  
8 appointed Steven Overbay as Acting Director of Administration; and

9           **WHEREAS**, the County Executive respectfully requests the approval for an extension of Sandra  
10 Edwards as Acting Economic Development Director for an additional period of four months.

11           **NOW THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
12 **MARYLAND**, confirms the recommendation by the County Executive of Sandra Edwards for an  
13 extension of four months as Acting Economic Development Director, which will expire on  
14 September 17, 2022.

15           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage  
16 by the County Council of Cecil County, Maryland.
