1 **WHEREAS**, Section 505 of the Charter of Cecil County requires the Executive to prepare a
2 Proposed Capital Improvement Program as part of the Budget Message to County Council for the
3 ensuing fiscal year not later than April 1 of each year; and

4 **WHEREAS**, the County Executive will submit on May 1, 2022 the proposed Capital Improvement
5 Program for Fiscal Years 2023-2027 to the Cecil County Planning Commission for review and
6 consideration; and

7 **WHEREAS**, any projects contained in the Capital Improvement Program for Fiscal Years 2023-2027
8 that require Planning Commission approval will be considered and recommended to remain part of the
9 Capital Improvement Program for Fiscal Years 2023-2027; and

10 **WHEREAS**, any projects contained in the Capital Improvement Program for Fiscal Years 2023-2027
11 that the Planning Commission does not recommend for approval will be amended and be removed from
12 Capital Improvement Program for Fiscal Years 2023-2027; and

13 **WHEREAS**, on April 1, 2022 the County Executive submitted the proposed Capital
14 Improvement Program for Fiscal Years 2023–2027 to the County Council, indicating the intention of the
15 County to receive and expend funds for capital projects, and providing for each capital project, the project
16 description, estimated costs and probable sources of funding; and

17 **WHEREAS**, the Cecil County Council has met all the requirements to consider the Capital
18 Improvement Program for Fiscal Years 2023–2027.

19 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
20 **MARYLAND**, that the Capital Improvement Program for the fiscal years ending June 30, 2023,
21 June 30, 2024, June 30, 2025, June 30, 2026, June 30, 2027, attached as Appendix 1, is approved and
22 adopted.

23 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
24 this Bill shall take effect on July 1, 2022.
