Supplemental Appropriation – Fund Balance – Courthouse – Parking Lot Capital Project

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021,
2 the County Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year
5 2022; and

6 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 1, 2021,
7 the Budget for Cecil County was approved for Fiscal Year 2022; and

8 **WHEREAS**, the County Executive is requesting to transfer \$120,000 from the fund balance
9 to the Courthouse Parking Lot Capital Project; and

10 **WHEREAS**, Section 506 of the Charter of Cecil County requires that no final budget action
11 may be taken by the County Council until after public hearing or hearings have been held in open
12 public session; and

13 **WHEREAS**, additional funds are required to complete the project because construction
14 costs has risen.

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for
17 Fiscal Year 2022 is hereby amended for the supplemental appropriation; and by amending the
18 Budget to appropriate expenditure authority within the Courthouse Parking Lot Capital Projects
19 Budget in the amount of \$120,000 from the fund balance.
