1 **WHEREAS**, a local jurisdiction may establish by local law a planning commission with the powers
2 and duties, pursuant to Section 2-101 in the Land Use Article of the Annotated Code of Maryland; and

3 **WHEREAS**, the Cecil County Board of Appeals shall consist of five regular members and one
4 alternate member, who must be residents of Cecil County; pursuant to Section 9-704 in the Land Use
5 Article of the Annotated Code of Maryland; and

6 **WHEREAS**, the Cecil County Board of Appeals shall be appointed by the County Executive and
7 approved by the County Council, pursuant to Section 298, Article XVI of the Cecil County Zoning Ordinance;
8 and

9 **WHEREAS**, the power and duties of the Board of Appeals are to hear and decide appeals when it is
10 alleged that there is an error in any order, requirement, decision, or determination made by the Zoning
11 Administrator or any other administrative official in the enforcement of the zoning ordinance; and to hear
12 and decide special exceptions as provided in the zoning ordinance; and to authorize upon application a
13 variance from the provisions of the zoning ordinance; and

14 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
15 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
16 and

17 **WHEREAS**, The County Executive has recommended the appointment of Norman Anderson to the
18 Cecil County Board of Appeals, to a three-year term, which is to expire on June 21, 2025.

19 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
20 **MARYLAND** confirms the recommendation by the County Executive of Norman Anderson for appointment
21 to the Cecil County Board of Appeals, to a three-year term, which is to expire on
22 June 21, 2025.

23 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that this
24 Resolution shall take effect on the date of its passage.
