1           **WHEREAS**, pursuant to Section 39-2 (C) of the Code of Cecil County, the County enacted the Cecil  
2 County Public Ethics Laws to guard against improper influence and to require County elected officials,  
3 officials, employees, and individuals appointed to boards and commissions to disclose their financial affairs  
4 and to set minimum standards for the conduct of local government business; and

5           **WHEREAS**, pursuant to Section 39-4(A) of the Code of Cecil County, the Cecil County Ethics  
6 Commission shall be composed of five members with staggered four year terms; and

7           **WHEREAS**, pursuant to Section 39-4(C) of the Code of Cecil County, no more than three members of  
8 the Commission shall be affiliated with the same political party; and

9           **WHEREAS**, pursuant to Section 39-04(B), all members shall reside in and be qualified voters of Cecil  
10 County; and

11           **WHEREAS**, pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all  
12 members of boards and commissions and that such membership shall be subject to confirmation by the  
13 Council; and

14           **WHEREAS**, the County Executive has recommended Janet Pope, for reappointment to the Cecil  
15 County Ethics Commission, who is registered Democrat, to a four year term, which is to expire on October  
16 3, 2025.

17           **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
18 **MARYLAND**, confirms the recommendation by the County Executive of Janet Pope, for reappointment to  
19 the Cecil County Ethics Commission, who is registered Democrat, to a four year term, which is to expire on  
20 October 3, 2025.

21           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all  
22 provisions of this Resolution shall take effect on the date of its passage.
