CALL TO ORDER

The meeting of the County Council of Cecil County of May 19, 2022, was called to order by Council President Meffley at 7:00 p.m. who Introduced Sheriff Scott Adams to lead the Pledge of Allegiance.

WELCOME AND INTRODUCTION

PUBLIC HEARINGS

Council Manager Massey stated for the record:

BILL NO. 2022-04 Capital Improvement Program - FY2023-2027

A Bill to approve the Capital Improvement Program for Cecil County for Fiscal Years 2023 through 2027.

BILL NO. 2022-05 Annual Budget and Appropriation Ordinance – FY 2023

A Bill to adopt the County Budget including the Current Expense Budget, Capital Budget, Special Purpose Budgets and Grants Budget for the fiscal year ending June 30, 2023, and to appropriate funds for all expenditures for the fiscal year beginning July 1, 2022.

RESOLUTION NO. 27-2022 Adoption - Real Property and Personal Property Tax Rates - Fiscal Year 2023

A Resolution to levy and impose a property and income tax for the fiscal year, beginning July 1, 2022 and ending June 30, 2023; setting the tax rates for property and providing for the collection of the property tax.

Diane Heath, Warwick, representing the Board of Education, asked for more funding for Cecil County Public Schools.

Kathleen Kennedy, Charlestown, commented in support of the proposed budget.

Marguerite Kennedy, Charlestown, commented in support of the proposed budget.

Katie Fortune, North East, commented that Cecil County Public Schools should be funded at a higher level than maintenance of effort.

Claiborne Stubbs, Chesapeake City, commented in support of the proposed budget.

Council President Meffley concluded the hearing and announced the final consideration of this legislation will be scheduled on Tuesday, June 7, 2022 at 7:00 p.m. during the Council legislative session, which is held in the Elk Room of the County Administration Building, 200 Chesapeake Blvd., Elkton, Maryland.
