**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, to provide a total of \$200,000 to the Special Revenue Other Grants Fund- Parks and Recreation to record the grant awarded from the Maryland Department of Natural Resources Water Way Improvement, to be used for the Engineering and Design of the Stoney Run, Route 7 (Old Philadelphia Road), Dredge Material Placement site (\$200,000).

**Supplemental Appropriation – Grant Funds – Parks and Recreation –**  
**Stoney Run Dredge Material Placement site**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2022; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 1, 2021, the  
6 Budget for Cecil County was adopted for Fiscal Year 2022; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2022 Special Revenue Other Grants  
8 Fund – Parks and Recreation revenue estimate for Cecil County to establish the following amount: the  
9 addition of \$200,000 in grant revenue and expense to the Special Revenue Other Grants Fund – Parks  
10 and Recreation budget to provide for the grant award from the Department of Natural Resources  
11 Water Way Improvement; and

12           **WHEREAS**, such appropriation is necessary to provide \$200,000 in grant funding for Engineering  
13 and Design of the Stoney Run, Route 7, (Old Philadelphia Road), Dredge Material Placement site.

14           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for  
16 Fiscal Year 2022 is hereby amended for the supplemental appropriation; and by amending the Current  
17 Budget to appropriate \$200,000 in additional expenditures in the Special Revenue Other Grants Fund –  
18 Parks and Recreation, to record the grant awarded from the Maryland Department of Natural  
19 Resources Water Way Improvement for the purpose of Engineering and Design of the Stoney Run,  
20 Route 7 (Old Philadelphia Road), Dredge Material Placement site.

21           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage  
22 by the County Council of Cecil County, Maryland.

### **SUMMARY OF LEGISLATION**

**SPONSOR:** Council President at the request of the County Executive

**RESOLUTION NO. 35-2022 Supplemental Appropriation – Grant Funds – Parks and Recreation – Stoney Run**

**SYNOPSIS:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, to provide a total of \$200,000 to the Special Revenue Other Grants Fund- Parks and Recreation, to record the grant awarded from the Maryland Department of Natural Resources Water Way Improvement, to be used for Design/Engineering of the Stoney Run Dredge Material Placement Site, Route 7 (Old Philadelphia Road), North East, Maryland.

**FISCAL IMPACT SUMMARY:** Net fiscal impact to the County will be zero for Fiscal 2022. The grant award is providing all funding to Design/Engineering for Stoney Run Dredge Material Placement Reclamation.

### **FISCAL ANALYSIS:**

The FY2022 capital budget includes \$200,000 in Department of Natural Resources Water Way Improvement Funding for the Engineering and Design of the Stoney Run, Route 7 (Old Philadelphia Road), Dredge Material Placement Reclamation project.

Cecil County Stoney Run, Route 7 (Old Philadelphia Road), Dredge Material Placement Site Engineering and Design (\$200,000): Cecil County will hereby commence with the Engineering and Design phase of the Stoney Run, Route 7 (Old Philadelphia Road, Dredge Material Placement site. Once completed the reclamation will permit the required construction needed for spoils acceptance.
