Supplemental Appropriation – Grant Funds – Liquor Board – Youth Empowerment Source – Drug Free Cecil

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2022; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on April 1, 2021, the  
6 Budget for Cecil County was adopted for Fiscal Year 2022; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2022 Special Revenue Other Grant Funds  
8 – Liquor Board revenue estimate for Cecil County to establish the following amount: the addition of  
9 \$10,000 in grant revenue to the Special Revenue Other Grant Funds – Liquor Board budget to provide for  
10 the grant from the Youth Empowerment Source awarded to Cecil County; and


11           **WHEREAS**, such appropriation is necessary to provide \$10,000 in program funding to allow for  
12 programs related to Drug Free Cecil.

13           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
14 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal  
15 Year 2022 is hereby amended for the supplemental appropriation, and by amending the Current Budget to  
16 appropriate \$10,000 in additional expenditures in the Special Revenue Other Grant Funds – Liquor Board, in  
17 order to record the grant awarded from the Youth Empowerment Source for the purpose of Drug Free  
18 Cecil.

19           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this  
20 Resolution shall take effect on the date of its passage.

#### **SUMMARY OF LEGISLATION**

**SPONSOR:** Council President at the request of the County Executive

**RESOLUTION NO. 37-2022 – Supplemental Appropriation – Grant Funds – Liquor Board – Youth Empowerment Source – Drug Free Cecil**

**SYNOPSIS:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2022, to provide a total of \$10,000 to the Special Revenue Other Grant Funds - Liquor Board, in order to record the grant awarded from the Youth Empowerment Source (YES) to be used as part of the Drug Free Cecil program.

**FISCAL IMPACT SUMMARY:** Net fiscal impact to the County will be zero for Fiscal 2022. The Youth Empowerment Source has awarded Cecil County \$10,000.

---

#### **FISCAL ANALYSIS:**

The addition of \$10,000 in grant revenue within the Special Revenue-Other Grant's Fund from the Youth Empowerment Source will fund programs related to Drug Free Cecil. This grant will be used to fund Stay Alert and Compliance Checks.
