Supplemental Appropriation and Budget Transfer – Capital Budget – Courtroom No. 3 – Courthouse Parking Lot

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2021,
2	the County Executive submitted a proposed budget to the County Council for Fiscal Year 2022; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council
4	held public hearings on the proposed budget submitted by the County Executive for Fiscal Year
5	2022; and
6	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 1, 2021,
7	the Budget for Cecil County was approved for Fiscal Year 2022; and
8	WHEREAS, the County Executive is requesting to transfer the Fiscal Year 2022 revenue
9	estimate within the Circuit Court Capital Projects Fund of \$12,218 from the Renovate Courtroom
10	No. 3 project to the Resurface Courthouse Parking Lot project. The transfer of bond expenditure
11	authority of \$12,218 will fund rising costs of the resurfacing project; and
12	WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action
13	may be taken by the County Council until after public hearing or hearings have been held in open
14	public session; and
15	WHEREAS, County Council has caused notice of a public budget hearing to be held on
16	August 2, 2022, on the recommended appropriation to be published in a newspaper of general
17	circulation in Cecil County; and
18	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
19	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for
20	Fiscal Year 2022 is hereby amended for the supplemental appropriation; and by amending the
21	Budget to appropriate expenditure authority within the Circuit Court Capital Projects Budget in the
22	amount of \$12,218, from the Renovate Courtroom No. 3 Project, to the Resurface Courthouse
23	Parking Lot Project.
24	BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND that
25	this Bill shall take effect 60 calendar days from the date that it becomes law.
