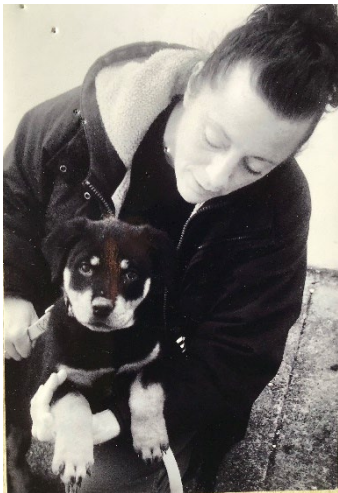


## Cecil County Commission for Women Member Biographies
