WHEREAS, in accordance with Section 505 of the Charter of Cecil County, Maryland, the County Executive submitted a proposed budget to the County Council for Fiscal Year 2023 on April 1, 2022; and WHEREAS, in accordance with Section 506 of the Charter of Cecil County, the County Council held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and WHEREAS, in accordance with Section 507(b) of the Charter of Cecil County, the county operating budget for Cecil County was adopted for Fiscal Year 2023 on June 7, 2022; and WHEREAS, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants Fund – Information Technology revenue estimate for Cecil County to establish the following amount: the addition of \$271,548 in grant revenue and expenses to the Special Revenue Other Grants Fund Information Technology operating budget in order to provide for the "Connected Communities" broadband grant from the Maryland Department of Housing and Community Development, administered by the Office of Statewide Broadband awarded to Cecil County; and WHEREAS, such appropriation is necessary to provide \$271,548 in funding for the purpose of improving wireless internet access at Calvert Park, the Cecil Arena, the Child Advocacy Center, the Circuit Courthouse, the Domestic Violence Center, the Help Center, and the Rising Sun Community Center. NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the Annual Budget and Appropriation Ordinance of Cecil County, Maryland, for Fiscal Year 2023 is amended for the supplemental appropriation; and by amending the Current Budget to appropriate \$271,548 in additional expenditures in the Special Revenue Other Grants Fund- Information Technology, to record the incentive awarded grant from the Maryland Department of Housing and Community Development, administered by the Office of Statewide Broadband, for the purpose of improving wireless internet access at Calvert Park, the Cecil Arena, the Child Advocacy Center, the Circuit Courthouse, the Domestic Violence Center, the Help
