2	April 1, 2022, the County Executive submitted a proposed budget to the County Council for
3	Fiscal Year 2023; and
4	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County
5	Council held public hearings on the proposed budget submitted by the County Executive for
6	Fiscal Year 2023; and
7	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on
8	June 7, 2022, the Budget for Cecil County was adopted for Fiscal Year 2023; and
9	WHEREAS, the County Executive is revising the Fiscal Year 2023 Special Revenue
10	Other Grants Fund - Parks and Recreation revenue estimate Cecil County in order to
11	establish the following amount: the addition of \$1,200,000 in grant revenue and expense to
12	the Special Revenue Other Grants Fund – Parks and Recreation budget to provide for the
13	grant award from the Department of Natural Resources; and

15	convert the stadium field at Rising Sun High School to synthetic turf.

22	Resources for the purpose of improving the quality of Cecil County parks and recreation for
23	the citizens of Cecil County.
