**Supplementary Appropriation – Grant Funds – Parks and Recreation
Rising Sun High School– Turf Field**

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on
2 April 1, 2022, the County Executive submitted a proposed budget to the County Council for
3 Fiscal Year 2023; and

4 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County
5 Council held public hearings on the proposed budget submitted by the County Executive for
6 Fiscal Year 2023; and

7 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on
8 June 7, 2022, the Budget for Cecil County was adopted for Fiscal Year 2023; and

9 **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue
10 Other Grants Fund - Parks and Recreation revenue estimate Cecil County in order to
11 establish the following amount: the addition of \$1,200,000 in grant revenue and expense to
12 the Special Revenue Other Grants Fund – Parks and Recreation budget to provide for the
13 grant award from the Department of Natural Resources; and

14 **WHEREAS**, such appropriation is necessary to provide \$1,200,000 in grant funding to
15 convert the stadium field at Rising Sun High School to synthetic turf.

16 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL**
17 **COUNTY, MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil
18 County, Maryland for Fiscal Year ending June 30, 2023 is hereby amended for the
19 supplemental appropriation; and by amending the Budget in order to appropriate
20 \$1,200,000 in additional expenditures in the Special Revenue Other Grants Fund – Parks and
21 Recreation, to record the grant awarded from the Maryland Department of Natural
22 Resources for the purpose of improving the quality of Cecil County parks and recreation for
23 the citizens of Cecil County.

24 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
25 **MARYLAND**, that this Resolution shall take effect on the date of its passage by the County
26 Council of Cecil County, Maryland.

SUMMARY OF LEGISLATION

SPONSOR: Council President at the request of the County Executive

RESOLUTION NO. 48-2022 – Supplemental Appropriation – Grant Funds – Parks and Recreation – Rising Sun High School - Turf Field

SYNOPSIS: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2023, in order to provide a total of \$1,200,000 to the Special Revenue Other Grants Fund – Parks and Recreation, to record the grant awarded from the Maryland Department of Natural Resources to be used for synthetic turf conversion of the stadium field at Rising Sun High School.

FISCAL IMPACT SUMMARY: Net fiscal impact to the County will be zero for Fiscal 2023. The grant award is providing all funding to convert the stadium field at Rising Sun High School.

FISCAL ANALYSIS:

The FY2023 capital budget (SB 291) includes \$85 million in general obligation bond funding for Local Parks and Playgrounds Infrastructure to be administered by the Maryland Department of Natural Resources. Cecil County was awarded \$1,500,000.

Senate Bill 291 of 2022 states that the capital budget authorization is for grants to the county administrative units managing local parks to design, construct and capital equip indoor and outdoor park infrastructure and other capital-eligible projects that enhance recreational amenities, including but not limited to trails, playgrounds, and recreational facilities.

The County has determined that \$1,200,000 of the grant shall be used to convert the stadium field at Rising Sun High School to a synthetic turf field.
