RESOLUTION NO. 46-2022
Approval – Franchise Agreement – Breezeline

1 **WHEREAS**, in accordance with Section A381 of the Code of Cecil County and Local Government
2 Article Section 1-702 of the Annotated Code of Maryland, the County Council is authorized to grant one
3 or more nonexclusive franchises to operate a cable television system within the County; and

4 **WHEREAS**, the County Council renewed an existing franchise and awarded a nonexclusive
5 franchise to Atlantic Broadband (DelMar) LLC, a Delaware Limited Liability Company, by
6 Resolution No. 02-2013 on February 5, 2013; and

7 **WHEREAS**, Breezeline (formerly Atlantic Broadband), operated by Cogeco US (Delmar), LLC, has
8 contacted the County requesting a renewal of the franchise agreement for a period of ten (10) years;
9 and

10 **WHEREAS**, the County Council finds that Breezeline (formerly Atlantic Broadband), operated by
11 Cogeco US (Delmar), LLC, has substantially complied with the material terms of its current franchise
12 and with both county and federal laws; and

13 **WHEREAS**, the County Council has determined that it is in the best interests of the citizens of
14 the county to renew the cable television franchise to Breezeline (formerly Atlantic Broadband),
15 operated by Cogeco US (Delmar), LLC, on the terms and conditions set forth in the franchise agreement
16 as Appendix 1.

17 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, that Breezeline (formerly Atlantic Broadband), operated by Cogeco US (Delmar), LLC, is
19 granted a renewal of its nonexclusive franchise to construct, operate, and maintain a cable television
20 system within the County for a period of ten (10) years from the effective date of this Act.

21 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND** that
22 this Resolution shall take effect on the date of its passage.
