**Synopsis:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2023, in order to provide a total of \$460,000 to the Special Revenue Other Grants Fund – Law Enforcement to record the grant awarded from the Governor’s Office of Crime Prevention, Youth and Victim Services for the Police Accountability, Community, and Transparency Grant (PACT) program.

**Supplemental Appropriation – Grant Funds – Law Enforcement –**  
**Police Accountability**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 5,  
2 2022, the County Executive submitted a proposed budget to the County Council for Fiscal  
3 Year 2023; and

4           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County  
5 Council held public hearings on the proposed budget submitted by the County Executive  
6 for Fiscal Year 2023; and

7           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June  
8 7, 2022, the Budget for Cecil County was adopted for Fiscal Year 2023; and

9           **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue  
10 Other Grants Fund – Law Enforcement revenue estimate for Cecil County to establish the  
11 following amount: the addition of \$460,000 in grant revenue to the Special Revenue  
12 Other Grants Fund – Law Enforcement budget to provide for the grant from the  
13 Governor’s Office of Crime Prevention, Youth and Victim Services awarded to Cecil  
14 County; and

15           **WHEREAS**, such appropriation is necessary to provide \$460,000 in program  
16 funding to allow for programs related Police Accountability, Community and  
17 Transparency.

18           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL**  
19 **COUNTY, MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil  
20 County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental  
21 appropriation and by amending the Current Budget to appropriate \$460,000 in additional  
22 expenditures in the Special Revenue Other Grants Fund – Law Enforcement in order to  
23 record the grant awarded from the Governor’s Office of Crime Prevention, Youth and  
24 Victim Services for the purpose of Police Accountability, Community and Transparency  
25 programs.

26           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
27 **MARYLAND**, that this Resolution shall take effect on the date of its passage.

#### **SUMMARY OF LEGISLATION**

**SPONSOR:** Council President at the request of the County Executive

**RESOLUTION NO. 56-2022 – Supplemental Appropriation – Grant Funds – Law Enforcement – Police Accountability**

**SYNOPSIS:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2023, to provide a total of \$460,000 to the Special Revenue Other Grants Fund – Law Enforcement to record the grant awarded from the Governor’s Office of Crime Prevention, Youth and Victim Services to be used for Police Accountability, Community and Transparency (PACT) programs.

**FISCAL IMPACT SUMMARY:** Net fiscal impact to the County will be zero for Fiscal 2023. The Governor’s Office of Crime Prevention, Youth and Victim Services has awarded Cecil County \$460,000.
