**Supplemental Appropriation – Grant Funds – Parks and Recreation –**  
**Elk River Dredge Survey**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1,  
2 2022, the County Executive submitted a proposed budget to the County Council for Fiscal  
3 Year 2023; and

4           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County  
5 Council held public hearings on the proposed budget submitted by the County Executive  
6 for Fiscal Year 2023; and

7           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June  
8 7, 2022, the Budget for Cecil County was approved for Fiscal Year 2023; and

9           **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue  
10 Other Grants Fund - Parks and Recreation revenue estimate Cecil County in order to  
11 establish the following amount: the addition of \$10,000 in grant revenue and expense to  
12 the Special Revenue Other Grant Funds – Parks and Recreation budget to provide for the  
13 grant award from the Department of Natural Resources; and

14           **WHEREAS**, such appropriation is necessary to provide \$10,000 in grant funding to  
15 conduct a Dredge Materials Placement site capacity survey for the Elk River.

16           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL**  
17 **COUNTY, MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil  
18 County, Maryland for Fiscal Year ending June 30, 2023 is hereby amended for the  
19 supplemental appropriation; and by amending the Budget in order to appropriate \$10,000  
20 in additional expenditures in the Special Revenue Other Grant Funds – Parks and  
21 Recreation, to record the grant awarded from the Maryland Department of Natural  
22 Resources Water Way Improvement for the purpose of improving the quality of Cecil  
23 County Parks and Recreation for the citizens of Cecil County.

24           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
25 **MARYLAND**, that this Resolution shall take effect on the date of its passage by the County  
26 Council of Cecil County, Maryland.

### **SUMMARY OF LEGISLATION**

**SPONSOR:** Council President at the request of the County Executive

**RESOLUTION NO. 57-2022 – Supplemental Appropriation – Grant Funds – Parks and Recreation – Elk River Dredge Survey.**

**SYNOPSIS:** A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2023, to provide a total of \$10,000 to the Special Revenue Other Grant Funds – Parks and Recreation, to record the grant awarded from the Maryland Department of Natural Resources to survey the remaining spoils capacity in the Elk River Dredge Materials Placement facility.

**FISCAL IMPACT SUMMARY:** Net fiscal impact to the County will be zero for Fiscal 2023. The grant award is providing all funding to perform the survey and provide data analysis.

### **FISCAL ANALYSIS:**

The Department of Natural Resources Water Way Improvement FY2023 capital budget affords funding for such projects throughout the State.

The County is hereby exercising it's right to utilize this funding to perform a capacity survey of the Elk River Dredge Materials Placement site. Data received from this survey will disclose the remaining capacity for future dredge cycles.
