Supplemental Appropriation – Grant Funds – Emergency Services – Laptops for Protocols

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 5, 2022, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6 Budget for Cecil County was adopted for Fiscal Year 2023; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants Fund
8 – Department of Emergency Services revenue estimate for Cecil County to establish the following amount:
9 the addition of \$9,026.15 in grant revenue to the Special Revenue Other Grants Fund – Department of
10 Emergency Services budget to provide for the grant from the Maryland 9-1-1 Board; and

11 **WHEREAS**, such appropriation is necessary to provide \$9,026.15 in funding to allow for Laptops for
12 Protocols for PSAP (Project # 23-119).

13 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
14 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
15 Year 2023 is hereby amended for the supplemental appropriation and by amending the Current Budget to
16 appropriate \$9,026.15 in additional expenditures in the Special Revenue Other Grants Fund – Department
17 of Emergency Services to record the grant awarded from the Maryland 9-1-1 Board for Laptops for
18 Protocols for PSAP (Project # 23-119).

19 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
20 Resolution shall take effect on the date of its passage.
