**Supplemental Appropriation-Grant Funds-Community Services-
Human Services Division-Food and Supplies**

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6 Budget for Cecil County was approved for Fiscal Year 2023; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants
8 Fund – Department of Community Services – Human Services Division revenue estimate Cecil County in
9 order to establish the following amount: the addition of \$15,686 in grant revenue and expense to the
10 Special Revenue Other Grants Fund – Department of Community Services – Human Services Division
11 budget to provide for the grant award from the Emergency Food and Shelter National Board Program;

13 **WHEREAS**, such appropriation is necessary to provide \$15,686 in grant funding for food and
14 supplies.

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year ending June 30, 2023 is hereby amended for the supplemental appropriation; and by amending
18 the Budget in order to appropriate \$15,686 in additional expenditures in the Special Revenue Other
19 Grant Fund – Department of Community Services – Human Services Division, to record the grant
20 awarded from the Emergency Food and Shelter National Board Program for the purpose of providing
21 food and supplies.

22 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
23 this Resolution shall take effect on the date of its passage.
