2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6	Budget for Cecil County was adopted for Fiscal Year 2023; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2023 Community Services Grant
8	Funds – Department of Community Services – Human Services Division revenue estimate for Cecil
9	County to establish the following amount: the addition of \$43,947.00 in grant revenue and expense to
10	the Community Services Grant Funds – Department of Community Services budget to provide for a
11	grant from the Maryland Governor's Office of Crime Prevention, Youth, and Victim Services; and

13	rental assistance to victims of domestic violence.
