Appointment – Public Safety Pension Plan Board of Trustees – Steven Overbay, Stephen Brownhill, Matthew Carr, Mary McLennan, Shon McCollum, Angela Blodgett, Wayne Tome, and Angelia Lawson

1           **WHEREAS**, the Plan and Trust were established by Resolution on April 16, 2002 by the Board of  
2 County Commissioners of Cecil County for the benefit of the Cecil County’s public Safety Employees;  
3 and

4           **WHEREAS**, the purpose of the plan is to attract and retain the highest quality public safety  
5 employees and to provide the Plan’s participants with retirement benefits in accordance with the  
6 terms, conditions, and provisions of the Plan, as set forth in the Plan document, the Trust Agreement,  
7 and applicable law; and

8           **WHEREAS**, pursuant to Article 7 Administration of the Plan. Section 7.1 Board of Trustees, the  
9 Pension Plan for Public Safety Employees designates a Board of Trustees as the administration of the  
10 Plan; and

11           **WHEREAS**, the Board of Trustees has oversight and day-to-day administration authority of the  
12 Public Safety Pension Plan; and

13           **WHEREAS**, the Board of Trustees members shall be required to select, monitor, and diversify  
14 the assets of the Pension Plan in accordance with the standards outlines in the Plan and Trust  
15 Agreement; and

16           **WHEREAS**, Article 7, Section 7.1 Board of Trustees, Subsection (a) (iii) specifies that the Board of  
17 Trustees will consist of the Cecil County Sheriff or his or her designee; and

18           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
19 Executive shall appoint all members of boards and commissions, subject to confirmation by the County  
20 Council; and

21           **WHEREAS**, the County Executive has recommended Steven Overbay to a two-year term, which  
22 will expire on December 31, 2024, Stephen Brownhill to a three-year term, which will expire on  
23 December 31, 2025, Matthew Carr to a one-year term, which will expire on December 31, 2023, Mary  
24 McLennan to a one-year term, which will expire on December 31, 2023, Shon McCollum, Angela  
25 Blodgett, Wayne Tome, and Angelia Lawson shall serve until their appointment ends or if such Trustee  
26 has been designated by a County officer, until the term of office or appointment of the County officer  
27 who appointed such trustee ends to the Public Safety Pension Plan Board of Trustees.

28           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
29 **MARYLAND** confirms the appointment by the County Executive of Steven Overbay to a two-year term,  
30 which will expire on December 31, 2024, Stephen Brownhill to a three-year term, which will expire on
