 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and,
 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and,
 WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 8, 2022, the

a.) The addition of \$9000 in expenditures for the Liquor Board Part-time inspector and boards salaries account and \$3500 in expenditures for the Liquor Board Training; and, \$2500 in expenditures for Supplies; and,

WHEREAS, such appropriation is necessary to provide \$15,000 of the County Executive's FY2023 assigned fund balance for the General Fund for expenditures; and,

NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation

Ordinance for Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental appropriation by amending the Current Budget to appropriate \$15,000 of additional expenditures from the General Fund to the Liquor Board budget.

SUMMARY OF LEGISLATION

SPONSOR: Council President at the request of the County Executive

RESOLUTION NO. 68-2022 - BUDGET TRANSFER - Fund Balance - Liquor Board

SYNOPSIS: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2023, to provide the Liquor Board budget within the General Fund expenditure appropriation authority to authorize \$15,000 to be expended for Liquor Board salaries, training, and supplies.

FISCAL IMPACT SUMMARY: The approval of this legislation will have a net fiscal impact on the Cecil County budget of \$15,000.

FISCAL ANALYSIS:

Additional \$15,000 will fund \$9,000 in expenditures for the Liquor Board Part-time inspector and boards salaries, \$3,500 for the Liquor Board Training, and \$2,500 for Supplies.
