- Economic Development Week:
  - County Exec gave Proclamation
  - Oct. 25 Hosted all-day Digital Marketing Workshop at North East Library
  - 28 attendees, potential for 26 grants of at least \$1,000 each; funded by USRC

- Recognized businesses for milestone anniversaries:
  - Crouse Auto Body 40 yrs.; Serenity Salon Spa & Tanning 15 yrs.; Painted Sky Alpaca Farm & Fiber Mill 10 yrs.; Plumpton Park Zoo 35 yrs.; Milburn Orchards 120 yrs. – Inform us of business milestone anniversaries for recognition

# An update on Maryland Rural Economic Development Fund was presented by Susan O'Neil, Executive Director, USRC

- Recap Gov. Hogan put in budget \$50M, \$10 per regional council to be distributed to Counties
- Money is for infrastructure, economic development activity, stimulate private investment, grow jobs
- Projects must be completed within 24 months
- Each regional council handled funding in own way, \$2.9M per county, \$1.3M for regional projects
- Counties submitted applications to USRC-USRC vetted for criteria-submitted to Commerce (246 pgs.)
- Cecil had 3 projects, Kent had 3 projects, Queen Anne's had 11 projects, 8 regional projects -submitted to USRC Executive Board
- Application in Governor's office for approval Once approved, USRC will receive funding, MOI or grant agreements to funnel money to counties
- Cecil County Projects outlines how much money going to each project
- \$37K set aside ≈ 1.5% of 3% for administrative costs
- Cecil divided into two groups: County Exec and County Council
  - \$1.9M Belvidere Road Improvement Project
  - Council Cecil County Farm Museum Regional Agricultural Center (ADA bathroom, commercial kitchen),
  - Paris Foundation (Create culinary employment for homeless individuals)
  - Unique projects no duplications
- Comprehensive economic development strategy established
- Regional Project: all 3 counties decided to put money into regional projects
  - No approach for marketing for business attraction each county has own DataStory but no marketing piece
  - Helps with business attraction but honors each county's needs and geography
  - USRC put together career technology liaison (Project Bright Future) for Queen Anne's County
  - Hired person Get high school kids interested in trades goes between businesses teaching them between internships to gaining employment

- Need career tech liaison for Cecil and Kent
- Goal: Kent person will run regional program; each county individualized to meet needs
  - Regional marketing pieces, regional advertising/website; obtain mobile labs (future)

# Director of Administration Update - Steve Overbay

- Welcome infusion of money for economic development projects in Cecil County
- Bulk of money will go to Belvidere Road Interchange
- Becoming more logistic-focused direct access to I-95 and Rt. 40 even more important
