Supplemental Appropriation – Sheriff’s Office – License Plate Reader Grant

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6 Budget for Cecil County was adopted for Fiscal Year 2023; and
7 **WHEREAS**, the County Executive is revising the Fiscal Year 2023 revenue estimate for Cecil
8 County to increase use of the Sheriff’s Office, to record a FY23 Local Agency License Plate Reader Grant
9 awarded from the Maryland Department of State Police for the purchase of License Plate Readers by
10 \$590,000; and
11 **WHEREAS**, the funds are paid quarterly on a reimbursable basis; and
12 **WHEREAS**, the Maryland Department of State Police will distribute awarded funds to grantees
13 on a reimbursement of expenditures basis when proof of delivery, receipt and proof of payment is
14 received; and
15 **WHEREAS**, such appropriation is necessary to provide \$590,000 of the County Executive’s
16 FY2023 assigned fund balance for the General Fund for expenditures; and
17 **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation
18 Ordinance for Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental
19 appropriation and by amending the Current Budget to appropriate \$590,000 of additional expenditures
20 in the General Fund to the Sheriff’s Office’s budget.
21 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage
22 by the County Council of Cecil County, Maryland.
