RESOLUTION NO. 09-2023
Appointment – Board of Parks and Recreation – Jennifer Callaghan – Kristen Lehr

1 **WHEREAS**, the Board of Parks and Recreation with powers and duties was created, pursuant to
2 Chapter 16, Article II, Section 16-7; and

3 **WHEREAS**, the Board of Parks and Recreation is authorized to determine all questions of
4 general policy relating to parks and public recreation in Cecil County, to supervise the expenditure of
5 funds appropriated to these purposes, and to keep the County informed as the availability of federal
6 and state funds for these purposes according to Chapter 16, Article II, Section 16-9 of the Code of Cecil
7 County; and

8 **WHEREAS**, the Board of Parks and Recreation shall consist of eight members, one member
9 being appointed by the Board of Education; and

10 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided
11 in subsection 412(c) or prescribed by State law or other provisions, that the County Executive shall
12 appoint all members of boards and commissions, subject to confirmation by the Council; and

13 **WHEREAS**, the County Executive has recommended Jennifer Callaghan for reappointment to
14 the Board of Parks and Recreation for a three (3) year term that will expire on December 31, 2026, and
15 Kristen Lehr who is replacing Matthew Morris whose term expires on April 1, 2025.

16 **NOW THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
17 recommendation by the County Executive of Jennifer Callaghan for reappointment to the Board of
18 Parks and Recreation for a three (3) year term, which is to expire on December 31, 2026, and Kristen
19 Lehr who is replacing Matthew Morris with a term to expire April 1, 2025.

20 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage
21 by the County Council of Cecil County, Maryland.
