WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
 WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
 Budget for Cecil County was adopted for Fiscal Year 2023; and
 WHEREAS, the County Executive is requesting to transfer \$250,000 from the fund balance to

WHEREAS, the County Executive is requesting to transfer \$250,000 from the fund balance to the Renovate State's Attorneys Offices capital project; and

WHEREAS, additional funds are required to complete the project because construction costs have risen; and

WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action may be taken by the County Council until after a public hearing or hearings have been held in open public session; and

WHEREAS, County Council has caused notice of a public budget hearing to be held on March 7, 2023, on the recommended appropriation to be published in a newspaper of general circulation in Cecil County.

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental appropriation and by amending the Budget to appropriate expenditure authority within the Renovate State's Attorneys Offices capital project budget in the amount of \$250,000 from fund balance.

AND BE IT FURTHER RESOLVED that this Bill shall take effect 60 calendar days from the date that it becomes law.
