Appointment—Local Management Board - John W. Donohue

WHEREAS, pursuant to Section 8-301, Subtitle 3, Title 8 of the Human Services Article of the
Annotated Code of Maryland, each county shall establish and maintain a local management board to
ensure the implementation of a local interagency service delivery system for children, youth, and
families; and
WHEREAS, pursuant to Section 8-302, a local management board may be composed of public
and private community representatives who share the responsibility for implementing a
community-based, interagency, family-focused service delivery system for children, youth, and
families; and
WHEREAS, pursuant to Section 8-303, a local management board shall strengthen the decision-
making capacity at the local level; design and implement strategies that achieve clearly defined results
for children, youth, and families; maintain standards of accountability for locally agreed upon results;
influence the allocation of resources across the system; build local partnerships to coordinate services;
and create an effective system of services, supports, and opportunities that improve outcomes for all,
and
WHEREAS, the Local Management Board in Cecil County is known as the Human Services
Agency; and
WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County, except as provided in
subsection 412(c) or prescribed by State law or other provisions, provides that the County
Executive shall appoint all members of boards and commissions, subject to confirmation by the
Council; and
WHEREAS, the County Executive has recommended the reappointment of John W. Donohue to
the Local Management Board to a four year term to expire on December 31, 2027.
NOW, THEREFORE, BE IT HEREBY RESOLVED BY THAT COUNTY COUNCIL OF CECIL COUNTY,
MARYLAND, confirms the recommendation by the County Executive of John W. Donohue for
reappointment to the local Management Board to a four year term that will expire on December 31,
2027.
AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage
by the County Council of Cecil County, Maryland.
