1	WHEREAS, a local jurisdiction may establish by local law a planning commission with the
2	powers and duties set forth in this division, pursuant to Section 2-101 Authority to Establish, Subtitle 1.
3	Organization and General Authority; Title 2. Planning Commission, Division 1. Single-Jurisdiction
4	Planning and Zoning, in the Land Use Article of the Annotated Code of Maryland; and
5	WHEREAS, the Cecil County Planning Commission was established and consists of six members
6	plus an alternate who shall serve in the absence of a regular member; and a member of the County
7	Council who serves as ex-officio, non-voting member; pursuant to Section 295. Planning Commission
8	Established, Part 1. Planning Commission; Article XVI. Administrative Mechanisms of the Cecil County
9	Zoning Ordinance; and
10	WHEREAS, each Planning Commission member serve three-year terms and must be a resident
11	of Cecil County; and
12	WHEREAS, the duties of the Planning Commission are to review, evaluate, and approve or
13	disapprove plans for subdivisions in accordance with the Zoning Ordinance and Subdivision
14	Regulations; and to review and make recommendations to the Cecil County Council regarding proposed
15	changes or amendments to the Comprehensive Plan, Chesapeake Bay Critical Area Program, Zoning
16	Ordinance, Subdivision regulations, Road Code, Master Water and Sewer Plan, acquisition and
17	development of lands for open space or recreation purposes, historic sites or districts, land use or
18	development arising from state or federal programs or policies, Forest Conservation Regulations; and
19	to review the Capital Improvement Program annually; and to make recommendations to the Board of
20	Appeals regarding applications for special exceptions; and
21	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided
22	in subsection 412(c) or prescribed by State law or other provisions, that the County Executive shall
23	appoint all members of boards and commissions, subject to confirmation by the Council; and
24	WHEREAS, The County Executive has recommended the appointment of Russell Johnson and
25	Charles Hicks to the Planning Commission to fill vacant 3- year terms that will each expire on December
26	31, 2025.
27	NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County, Maryland,
28	confirms the recommendation by the County Executive of Russell Johnson and Charles Hicks for

appointment to the Planning Commission; for a 3- year term, which is to expire on December 31, 2025.
