1	WHEREAS, the Board of Parks and Recreation with powers and duties was created, pursuant to
2	Chapter 16, Article II, Section 16-7; and
3	WHEREAS, the Board of Parks and Recreation is authorized to determine all questions of
4	general policy relating to parks and public recreation in Cecil County, to supervise the expenditure of
5	funds appropriated to these purposes, and to keep the County informed as the availability of federal
6	and state funds for these purposes according to Chapter 16, Article II, Section 16-9 of the Code of Cecil
7	County; and
8	WHEREAS, the Board of Parks and Recreation shall consist of eight members, one member
9	being appointed by the Board of Education; and
10	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides, except as provided
11	in subsection 412(c) or prescribed by State law or other provisions, that the County Executive shall
12	appoint all members of boards and commissions, subject to confirmation by the Council; and
13	WHEREAS, the County Executive has recommended Jennifer Callaghan for appointment to the
14	Board of Parks and Recreation for a three (3) year term that is currently vacant to expire on December
15	31, 2026, and Kristen Lehr who is replacing Matthew Morris's whose term expires on April 1, 2025.
16	NOW THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the
17	recommendation by the County Executive of Jennifer Callaghan the Board of Parks and Recreation for a
18	three (3) year term, which is to expire on December 31, 2026, and Kristen Lehr with a term to expire
19	April 1, 2025.
