Supplemental Appropriation – Landfill Enterprise Fund Balance – Solid Waste Division, DPW  
Budget Amendment

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public  
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 07, 2022, the  
6 Budget for Cecil County was adopted for Fiscal Year 2023; and

7           **WHEREAS**, the additional funding is requested due to the Solid Waste Management Division Gasoline  
8 & Oil account being under-funded in Fiscal Year 2023; and

9           **WHEREAS**, the additional funding of \$150,000 is being requested from the Enterprise Landfill Fund  
10 Balance to mitigate the increased fuel expense; and

11           **WHEREAS**, the additional funds are required to enable the Department of Public Works, Solid Waste  
12 Management Division to have adequate funding for Fiscal Year 2023.

13           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
14 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal Year  
15 2023 is hereby amended for the supplemental appropriation; in the amount totaling \$150,000 to mitigate  
16 increased fuel expense.

17           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this  
18 Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
