Supplemental Appropriation-Parks and Recreation-Program Revenue and Self-Funding Program Expense

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4	hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the Budget
6	for Cecil County was adopted for Fiscal Year 2023; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2023 Program Revenue and Expenditure
8	Account for Parks and Recreation of Cecil County, which requires the transfer of \$25,000 from the Program
9	Revenue Account to the Expenditure Account to cover the costs associated with increased programs; and
10	WHEREAS, such appropriation is necessary given an increase of \$25,000 in additional Program
11	Revenue and to offset the Expenditure Account by \$25,000 for costs associated with program increases; and
12	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance for
13	Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental appropriation and by
14	amending the Current Budget to appropriate \$25,000 in additional Program Revenue, and to offset the
15	Expenditure Account by \$25,000 for the Cecil County Parks and Recreation.
16	AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by the
17	County Council of Cecil County, Maryland.
