**RESOLUTION NO. 17-2023**

Supplemental Appropriation – General Fund Balance–  
Additional Utility Funding – Facility Management - Budget  
Amendment

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the  
6 Budget for Cecil County was adopted for Fiscal Year 2023; and

7           **WHEREAS**, the additional funding is being requested due to the higher than budgeted electricity  
8 cost for Facilities Management; and

9           **WHEREAS**, the additional funding of \$79,000 is being requested from the General Fund Balance  
10 to mitigate the increased electricity expense; and

11           **WHEREAS**, the additional funds are required to enable Facilities Management to have adequate  
12 funding for the remainder of Fiscal Year 2023.

13           **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation  
14 Ordinance for Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental  
15 appropriation; in the amount totaling \$79,000 to mitigate increased electricity costs.

16           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage  
17 by the County Council of Cecil County, Maryland.
