1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4	hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the Budget
6	for Cecil County was adopted for Fiscal Year 2023; and
7	WHEREAS, the additional funding is requested due to the supply chain issues, Enterprise was not able
8	to provide new cars; and
9	WHEREAS, the repairs and maintenance budget was reduced in lieu of the anticipated costs savings
10	from the Enterprise contract; and
11	WHEREAS, the additional funding of \$530,000 will be provided from the General Fund Balance to the
12	Motor Vehicle Internal Service Fund for repairs and maintenance costs for the remainder of FY23.
13	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
14	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal Year
15	2023 is hereby amended for the supplemental appropriation in the amount of \$530,000 from the General
16	Fund Balance to the Motor Vehicle Internal Service Fund for repairs and maintenance costs.
