1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6	Budget for Cecil County was adopted for Fiscal Year 2023; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants
8	Fund, Department of Public Works, Roads Division revenue estimate Cecil County in order to establish
9	the following amount: the addition of \$10,681 in grant revenue; and
10	WHEREAS, the Roads Division completed site lighting improvement at the Southern Yard
11	located at 146 S. Bohemia Avenue, Cecilton, MD; and
12	WHEREAS, using Delmarva Power grant funding program called "Delmarva Power Energy
13	Savings for Business Program"; and
14	WHEREAS, Triumph Electric completed the work and who is a preapproved contractor with
15	Delmarva Power, they performed a site audit, estimate of work, construction, and post construction
16	processing to obtain the program incentive; and
17	WHEREAS, roads division performed the work under the Facilities Maintenance Account and
18	issued a Purchase Order to Triumph Electric; and
19	WHEREAS, such appropriation is necessary to deposit \$10,681 to be deposited back into the
20	Facilities Maintenance Account to continue to fund the general maintenance of all three facilities.
21	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
22	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fisca
23	Year ending June 30, 2023, is hereby amended for the supplemental appropriation and by amending
24	the Current Budget to appropriate \$10,681 of additional expenditures in the Special Revenue Other
25	Grants Fund, Department of Public Works, Roads Division General Fund to record the grant awarded
26	from Delmarva Power and to deposit \$10,681 back into the Facilities Maintenance Account.
27	AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND that
28	this Resolution shall take effect on the date of its passage.
