**Title of Resolution:** Budget Amendment – Special Revenue Other Grants – Grant from the Maryland Department of Natural Resources Waterway Improvement Funding – Parks and Recreation.

**Synopsis:** A resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2023, to provide a total of \$2,196,750 to the Special Revenue Other Grants Fund- Parks and Recreation to record the grant awarded from the Maryland Department of Natural Resources Waterway Improvement to be used for the Engineering, Inspection, and Construction of the Stoney Run, Route7, DMP site (\$2,196,750).

Budget Amendment-Special Revenue Other Grants-Grant from Maryland  
Dept of Natural Resources Waterway Improvement Funding-Parks and  
Recreation

1       **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3       **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public  
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5       **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the Budget  
6 for Cecil County was adopted for Fiscal Year 2023; and

7       **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants Fund  
8 – Parks and Recreation revenue estimate for Cecil County to establish the following amount: the addition of  
9 \$2,196,750 in grant revenue and expense to the Special Revenue Other Grants Fund – Parks and Recreation  
10 budget to provide for the grant award from the Department of Natural Resources Waterway Improvement;

12       **WHEREAS**, such appropriation is necessary to provide \$2,196,750 in grant funding for Engineering,  
13 Inspection and Construction of the Stoney Run, Route 7, DMP site.

14       **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for  
15 Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental appropriation and by  
16 amending the Current Budget to appropriate \$2,196,750 in additional expenditures in the Special Revenue  
17 Other Grants Fund – Parks and Recreation to record the grant awarded from the Maryland Department of  
18 Natural Resources Waterway Improvement for the purpose of Engineering, Inspection and Construction of  
19 the Stoney Run, Route 7, DMP site.

20       **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
21 County Council of Cecil County, Maryland.
