## RESOLUTION NO. 16-2023 periff of Cecil County - Salary

**Sheriff of Cecil County - Salary** WHEREAS, In 2016, House Bill 816 was passed into law by the General Assembly and Governor of Maryland that amended the Courts and Judicial Proceedings Article, Section 2-309(i)(1)(i) that set the annual salary for the Sheriff of Cecil County through fiscal year 2019; and WHEREAS, Section 2-309(i)(1)(i)(6) of the Annotated Code of Maryland noted for each term of office for the Sheriff of Cecil County beginning with the term that begins in fiscal year 2019, not less than \$100,000, as determined by the County Council of Cecil County shall be the annual salary for the Sheriff of Cecil County; and WHEREAS, Section 2-309(i)(1)(i)(6) of the Annotated Code of Maryland grants the County Council the ability to determine the salary of the Sheriff of Cecil County after fiscal year 2019; and WHEREAS, The County Council of Cecil County reviewed the annual salaries of the Sheriff of Cecil County and the annual salary of other Offices of Sheriff in comparable jurisdictions in the State of Maryland; and WHEREAS, The County Council determined that based upon this review and the responsibilities of the Sheriff of Cecil County and other Offices of Sheriff in Maryland, the compensation for this office should be adjusted; and WHEREAS, Article 5, Section 504 of the Charter of Cecil County, directs the County Executive to prepare and propose a Budget to the Council for the ensuing fiscal year; and WHEREAS, The County Council has determined in accordance with the Annotate Code of Maryland Section 2-309(i)(1)(i)(6) the salary of the Sheriff of Cecil County should be set at \$127,000 annually beginning at the start of FY24. NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County, as per Section 2-309(i)(1)(i)(6) of the Annotated Code of Maryland approves the adjustment to the salary for the Sherriff of Cecil County to \$127,000 annually and directs the County Executive to adjust the FY24 Budget to reflect an annual salary for the Sheriff of Cecil County to be \$127,000 annually.
