Supplemental Appropriation – Grant Funds – Community Services –
Human Services Division – Domestic Violence/Child Advocacy Center

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6 Budget for Cecil County was adopted for Fiscal Year 2023; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Community Services Grants
8 Fund, Department of Community Services, Human Services Division revenue estimate for Cecil County
9 to establish the following amount: the addition of \$40,304 in grant revenue and expense to the
10 Community Services Grants Fund, Department of Community Services budget to provide for a grant
11 from the Maryland Governor’s Office of Crime Prevention, Youth, and Victim Services; and

12 **WHEREAS**, such appropriation is necessary to provide \$40,304 in grant funding to supplement
13 efforts in responding to human trafficking in Cecil County.

14 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
16 Year 2023 is hereby amended for the supplemental appropriation and by amending the Current Budget
17 to appropriate \$40,304 of additional expenditures in the Community Services Grants Fund, Department
18 of Community Services to record the grant awarded from the Maryland Governor’s Office of Crime
19 Prevention, Youth, and Victim Services

20 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
21 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
22 Maryland.
