Reappointment and Appointment– Weed Control Advisory Board

1           **WHEREAS**, Pursuant to Maryland Annotated Code, Agriculture Article, Section 9-2402(4), the  
2 Secretary of Agriculture may enter into agreements with any county subdivision of the State to  
3 effectuate a program of control and eradication of noxious weeds; and

4           **WHEREAS**, Pursuant to a Memorandum of Understanding between the Maryland Department  
5 of Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on  
6 March 16, 2010, the Cecil County Board of Commissioners agreed to appoint a Weed Control Advisory  
7 Board to assist the Department of Agriculture in developing and implementing a Noxious Weed Control  
8 Program; and

9           **WHEREAS**, the Weed Control Advisory Board of Cecil County works with the Roads Division of  
10 the Department of Public Works in providing oversight for the weed control program; and

11           **WHEREAS**, Article 4, Section 412(b) of the Charter of Cecil County, except as provided in Section  
12 412(c) or prescribed by State law or other provisions, the County Executive shall appoint all members  
13 of boards and commissions and that such membership shall be subject to confirmation by the Council;  
14 and

15           **WHEREAS**, the Weed Control Advisory Board of Cecil County works with the Roads Division of  
16 the Department of Public Works in providing oversight for the weed control program; and

17           **WHEREAS**, the County Executive has recommended Robert Weaver, Jim Calao, Charles Herzog,  
18 Kenneth Newcomb, Doris Behnke, and Ryan Fisher, Carroll Michael Scheeler, William Ewing, Jessica  
19 Edge, Scott Heaps, for reappointment to the Cecil County Weed Control Advisory Board for a one (1)  
20 year term, to expire April 19, 2024 and to confirm the appointment of John Fabian, for a one (1) year  
21 term, to expire April 19, 2024 to the Cecil County Weed Control Advisory Board.

22           **NOW THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
23 **MARYLAND**, confirms the recommendation by the County Executive of Robert Weaver, Jim Calao,  
24 Charles Herzog, Kenneth Newcomb, Doris Behnke, and Ryan Fisher, Carroll Michael Scheeler, William  
25 Ewing, Jessica Edge, Scott Heaps, for reappointment to the Cecil County Weed Control Advisory Board  
26 for a one (1) year term, to expire April 19, 2024 and to confirm the appointment of John Fabian, for a  
27 one (1) year term, to expire April 19, 2024 to the Cecil County Weed Control Advisory Board.
