Operational Budget

On Thursday, January 19, the Director met with County Finance Director Shon McCollum and the new Budget Manager to discuss the FY24 budget. They were joined by County Executive Hornberger and County Administrator Overbay, who observed but did not otherwise participate. The Director and Budget Manager had a follow-up meeting on January 27 to clear up unresolved questions of accounting for salaries/benefits of state employees, details of professional and related services relating to the SBE quarterly billing and updating projected costs for the MAEO Annual Meeting and SBE mandatory biennial training. The final budget meeting with the above listed parties scheduled for Tuesday, March 14 has been pushed back to Tuesday, March 21, 2023.

Election Deputy Director Vacancy

The Director has submitted an updated vacancy announcement to the SBE HR office for immediate posting this week.

Election IT Specialist Contractor

Jasmine Barnette, who served as SBE Regional Manager vice Russell Hicks, has joined our team as a State contractor. Jasmine had an in-person handoff from Nathan Reynolds with whom she worked throughout the Gubernatorial General Election and is now conducting the State-

required Post-Election Maintenance (PEM). Jasmine has also been a contractor for Election Systems and Software (ES&S) and an election program staffer for the Baltimore City LBE.

Pending Legislation

HB 410, the Election Reform Act and HB 1200 (SB 925) pertaining to minimum compensation for election judges received second readings on the House floor Tuesday, March 14. The election judge compensation bill (SB 925) is scheduled for a hearing in the Senate Wednesday, March 15. The proposal to change the date of the Presidential Primary has been attached to different bills, the Election Reform bill (HB 410) in the House and, in the Senate, it is attached to SB 379 the ballot processing and reporting procedures bill. Resolving the difference could make for interesting viewing.

SB 379, which alters the procedures for the canvassing of and curing of errors on absentee and provisional ballots has passed each chamber, though with different amendments, and is considered well on its way to final passage.

SB 750 (HB 1216) requiring proof of identity in order to vote is not expected to be passed out of committee.

HB 645 (SB 488) requiring the Department of Legislative Services (DLS) to complete a study on the creation of an electronic ballot return system and requiring SBE to issue a request for proposals for an electronic ballot return system by January 1, 2024 was referred for an interim study by the Ways and Means Committee, after an amendment providing for a MAEO seat at the DLS review table study was defeated.

Board Member Ethics Filing

After the April 30 Ethics Commission filing, Board members who are not serving another term will be required to submit an "end of service" ethics filing which can be completed on the same Commission web page you use for periodic filings.

SBE 2022 Gubernatorial Election Audit Report

Staff is reviewing and preparing a response to SBE's audit of the 2022 Gubernatorial Election in Cecil County. The report and response will be shared with the Board under separate cover and the response requires the signature of the President and the Director.

2023 MAEO Conference

MAEO will convene the Annual Meeting May 14-19, 2023 in Worcester County. The MAEO board selected the theme: "MAEO—Making It Count" and approved a registration fee of \$250 per attendee. Single Day registration for Tuesday, Wednesday, and Thursday is \$165/day. Food costs are approximately \$500/person, so any guests will be required to pay the registration fee. The hotel room rate ranges from \$159/night Queen-\$179 for a suite. MAEO is negotiating with nearby hotels for overflow accommodations. Making reservations by phone will avoid the need to provide a personal credit card for a deposit. The deposit has been waived, but that waiver cannot be honored in online transactions. MAEO has just circulated a tentative agenda and updated registration for that are included in the meeting materials.

May Board Meeting Date

The May 17, 2023 Board meeting has, at the Board's direction, been rescheduled for May 24 in order to avert conflict with the May 14-19 MAEO Conference.

MAEO Committee Work

The Director has accepted an invitation to co-chair MAEO's Constitution and Bylaws Committee with Anthony Gutierrez, Frederick County Deputy Election Director.

SBE Biennial Pre-Election Training

COMAR Title 33.02.02.01, Statewide Biennial Meeting, requires all local Board members, Board Counsel, Election Directors and Deputy Directors, and other staff as assigned by the State Administrator, or LBEs to attend a Statewide biennial meeting to instruct local board members, counsel, and staff on the proper conduct of elections. SBE would ordinarily conduct this session at the MAEO Annual Meeting. However, since MAEO has scheduled its meeting in May, prior to the seating of new LBEs, SBE will schedule the Biennial Meeting for September or October in Annapolis. We anticipate this will be a one-day meeting not requiring overnight accommodation.
