2	Chapter 16, Article II, Section 16-7; and
3	WHEREAS, the Board of Parks and Recreation is authorized to determine all questions of
4	general policy relating to parks and public recreation in Cecil County, to supervise the expenditure of
5	funds appropriated to these purposes, and to keep the County informed as the availability of federal
6	and state funds for these purposes according to Chapter 16, Article II, Section 16-9 of the Code of Cecil
7	County; and
8	WHEREAS, the Board of Parks and Recreation shall consist of eight members, one member
9	being appointed by the Board of Education; and
10	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County, except as provided in
11	Section 412(c) or prescribed by State law or other provisions, provides that the County Executive shall
12	appoint all members of boards and commissions, subject to confirmation by the Council; and
13	WHEREAS, the County Executive has recommended Brian Morgan for reappointment to the
14	Board of Parks and Recreation for a three (3) year term that will expire on March 17, 2026.
15	NOW THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the
16	recommendation by the County Executive of Brian Morgan to the Board of Parks and Recreation for a
17	three (3) year term, which is to expire on March 17, 2026.
18	AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage
19	by the County Council of Cecil County, Maryland.
