**RESOLUTION NO. 25-2023**

Supplemental Appropriation – Grant Funds – Department of Public Works – Wastewater Division – Maryland Department of the Environment – Bay Restoration Fund Operation & Maintenance Grants

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the County  
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public  
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the Budget  
6 for Cecil County was adopted for Fiscal Year 2023; and

7           **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants Fund for  
8 the Department of Public Works, Wastewater Division revenue estimate for Cecil County to establish the  
9 following amount: the addition of \$75,627 in grant revenue for the North East River Facility and \$30,202 in grant  
10 revenue for the Harborview Facility for the Special Revenue Other Grants Fund for the Department of Public  
11 Works, Wastewater Division budget to provide for the grant from the Maryland Department of the Environment  
12 Awarded to Cecil County; and

13           **WHEREAS**, such appropriation is necessary to provide \$105,829 to help cover the costs associated with  
14 achieving Enhanced Nutrient Removal level of treatment, chemicals, electricity, laboratory cost, etc.

15           **NOW THEREFORE, BE IT HEREBY RESOLVED** that the Annual Budget and Appropriation Ordinance for Cecil  
16 County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental appropriation and by amending  
17 the Current Budget to appropriate \$105,829 of additional expenditures, in the Special Revenue Other Grant  
18 Fund for the Department of Public Works, Wastewater Division, in order to record the grant awarded from the  
19 Maryland Department of the Environment, for the purpose of achieving Enhanced Nutrient Removal level of  
20 treatment, chemicals, electricity, laboratory cost, etc. in Cecil County by the County Council of Cecil County,  
21 Maryland.

22           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the  
23 County Council of Cecil County, Maryland.
