## **Operational Budget**

At a final budget meeting with the Finance Director and Budget Manager, on March 21, the Director was informed that the Executive's office had agreed to all of the Election Board's requests except that participation in the MAEO Annual Conference would be capped at \$10,000. The Director appeared at the second of six Council Budget Hearings on Tuesday, April 11. While showing no indication of their ultimate votes, the Council asked reasonable and informed questions about election judge compensation, potential equipment needs, and whether the cut/cap in training affected election judge training or staff training. The Director is scheduled to

appear at the Thursday, May 18, 2023 Public Budget Hearing at Elkton High School during the MAEO Conference. The Council has scheduled Budget deliberation sessions on May 23 and 30 and is expected to vote on final adoption of the FY24 Budget at the June 6 Council Legislative Session.

## **Election Deputy Director Vacancy**

Four applicants have met SBE qualifications for the Deputy Director Position. SBE Human Resources requires us to interview all of them, and all have responded affirmatively to interview invitations. Interviews are scheduled for Tuesday, April 18.

## **General Assembly Recap**

The Director thanks all Board members for agreeing to sign-on to the March 24 letter to Sen. Jason Gallion opposing the House version of HB410. Sen. Gallion was kind enough to meet with the Director regarding the bill immediately prior to the March 28 Senate Education, Energy, and the Environment Committee hearing at which it was considered. Sen. Gallion did not indicate his voting preference but did provide the helpful observation that Committee Chair Sen. Brian Feldman had to that point demonstrated an inclination to support passage of all bills to clear the House of Delegates with a unanimous vote as HB410 had done. This information was shared with the MAEO and SBE legislative teams. The Senate ultimately amended HB410, even altering the title from "Election Reform Act of 2023" to "Elections—Polling Place Plan, Prohibited Acts, and 2024 Primary Election Date."

Key takeaways from the 2023 General Assembly session include:

- The date of the Presidential Primary is being moved three weeks later to May 14, 2024;
- Election judge compensation:
  - o has been reset to a minimum of \$250 per day;
  - o bonuses of \$100 are per day worked, not just one time.
    - State/County 50/50 split of the cost amended to bill.
    - Implementing regulations are TBD;
- New mandatory Polling Place Plans will be due to SBE by December 2023.

# **Board Member Ethics Filing**

A reminder, after the April 30 Ethics Commission filing, Board members who are not serving another term will be required to submit an "end of service" ethics filing which can be completed on the same Commission web page you use for periodic filings.

## 2023 MAEO Conference

MAEO will convene the Annual Meeting May 14-19, 2023 in Worcester County. The MAEO board selected the theme: "MAEO—Making It Count" and approved a registration fee of \$250 per attendee. Single Day registration for Tuesday, Wednesday, and Thursday is \$165/day. Food costs are approximately \$500/person, so any guests will be required to pay the registration fee. The hotel room rate ranges from \$159/night Queen-\$179 for a suite. MAEO is negotiating with nearby hotels for overflow accommodations. Reservations have been made for President Sengstock, members Jennifer Graham and Stephen Stiles, and incoming members Holcombe Grier and Krista Moretz, and four staff members. Incoming member Eunice Grant is unable to attend due to a conflict. An updated detailed agenda is included in the meeting materials

#### **MAEO Committee Work**

The Director has accepted an invitation to co-chair MAEO's Constitution and Bylaws Committee with Anthony Gutierrez, Frederick County Deputy Election Director. At its March 31 Meeting the MAEO Board referred a motion tasking the Constitution and Bylaws Committee to draft a MAEO code of conduct or ethics to which MAEO members would agree on accepting membership.

## **SBE Biennial Pre-Election Training**

COMAR Title 33.02.02.01, Statewide Biennial Meeting, requires all local Board members, Board Counsel, Election Directors and Deputy Directors, and other staff as assigned by the State Administrator, or LBEs to attend a Statewide biennial meeting to instruct local board members, counsel, and staff on the proper conduct of elections. SBE would ordinarily conduct this session at the MAEO Annual Meeting. However, since MAEO has scheduled its meeting in May, prior to the seating of new LBEs, SBE has scheduled the Biennial Meeting for Thursday, October 19 in Annapolis.

## **New SBE Chief Information Security Officer**

SBE hired new Chief Information Security Office Patrick Angel

## **Pollbook Project Update**

Cecil County is scheduled to obtain 133 new electronic pollbooks at a cost of \$735 per unit. SBE has received and is testing all of the pollbooks. Initial testing of the pollbook tablets was complete with only one failure. Hub testing to verify network connectivity is approximately 50% complete as of April 12. Installation of new foam inserts into pollbook cases anticipated in late June. MAEO has convened monthly project status update.

b. At the suggestion of Board Counsel, staff will make the disclaimer language on the application form consistent with that on the State Board request form.
