## **RESOLUTION NO. 31-2023**

Reappointment – Electrical Examiners Board – Joshua Huegel, Frederick Craig, Jr. and Appointment Paul Palmer

WHEREAS, Pursuant to Article II, Section 191-6A of the Code of Cecil County, the County Executive shall appoint a board which shall be known as the "Board of Electrical Examiners," consisting of seven persons for the purpose of examining the qualifications and capabilities of all persons who are engaged in, or desire to engage in the business of master electrician or limited electrician as defined in this chapter; and WHEREAS, Pursuant to Chapter 191, Article II, Section 191-10 of the Code of Cecil County, the Board of Electrical Examiners shall advise the County, and aid in the supervision and enforcement of any rule or regulation adopted, pursuant to the authority of the Code and Maryland law; and the Board shall act as an appeals board concerning matters arising under the adopted code and any licensing provisions; and WHEREAS, Pursuant to Article II, Section 191-6B of the Code of Cecil County, the County Executive shall appoint seven members, all being residents of Cecil County, and so appointed shall consist of at least four persons who are master electricians, and one member shall be a person whose name appears on a list of candidates recommended by the Cecil County Fireman's Association, if submitted; and WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County, except as provided in Section 412(c) or prescribed by State law or other provisions, provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and WHEREAS, the County Executive has recommended Joshua Huegel for reappointment to expire on November 19, 2025, Frederick Craig, Jr., to expire January 1, 2026, and appointment of Paul Palmer to fill a vacancy to expire May 31, 2026, to the Electrical Examiners Board for three-year terms. NOW THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, confirms the recommendation by the County Executive of the reappointment of Joshua Huegel to expire November 19, 2025, Frederick Craig, Jr., to expire January 1, 2026, and the appointment of Paul Palmer to fill a vacancy to expire May 31, 2026, to the Electrical Examiners Board for three-year terms. AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage
