Title of Resolution: Supplemental Appropriation - Grant Funds – Community Services – Prevention and Overdose Response and Trauma Supports.

Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2023, in order to provide a total of \$28,146 to the Special Revenue Other Grants Fund to record the Memorandum of Understanding (MOU) Inter-Agency Agreement between the Cecil County Health Department and the Cecil County Department of Community Services. The agreement provides funding for educational, promotional, and training items for the PORT team members and basic supplies and personal care items for individuals experiencing addiction as distributed by the PORT team members.

Supplemental Appropriation - Grant Funds – Community Services-
Prevention and Overdose Response and Trauma Supports

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the
6 Budget for Cecil County was adopted for Fiscal Year 2023; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2023 Special Revenue Other Grants
8 Fund – Department of Community Services revenue estimate for Cecil County to establish the following
9 amount: the addition of \$28,146 in grant revenue and expense to the Special Revenue Other Grants
10 Fund – Department of Community Services budget to provide for the grant from the Cecil County
11 Health Department awarded to Cecil County through an MOU; and

12 **WHEREAS**, such appropriation is necessary to provide \$28,146 in grant funding to provide basic
13 supplies and personal care items for individuals experiencing addiction as distributed by the PORT
14 members, and educational, training and promotional items for the PORT team members; and

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year 2023 is hereby amended for the supplemental appropriation and by amending the Current Budget
18 to appropriate \$28,146 of additional revenue and expense in the Special Revenue Other Grants Fund –
19 Department of Community Services to record the agreement providing funding to support PORT team
20 initiatives.

21 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
22 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
23 Maryland.
