Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2023, in the amount totally \$417,000 from the General Fund Balance to Law Enforcement's budget for the expenditure appropriation authority to purchase an Armored Rescue/Tactical (SRT) vehicle for \$400,000 and a Crossover Utility Vehicle (CUV) for \$17,000.

Supplemental Appropriation – General Fund Balance – Law Enforcement Armored Rescue Vehicle and Crossover Utility Vehicle

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2022, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2023; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4	hearings on the proposed budget submitted by the County Executive for Fiscal Year 2023; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2022, the Budget
6	for Cecil County was adopted for Fiscal Year 2023; and
7	WHEREAS, additional funding is being requested for the purchase of an Armored Rescue/Tactical
8	(SRT) vehicle for the protection of public safety officers for \$400,000. The vehicle will be utilized for response
9	to barricaded suspects, execution of high-risk warrants, rescue of injured persons during an active shooter
10	or riot incident and evacuation of dangerous areas during environmental emergencies. The purchase will
11	make Cecil County Law Enforcement self-sufficient, not rely on neighboring jurisdictions when dangerous
12	situations arise and when time is of the essence. Furthermore, additional funding is being requested for the
13	purchase of a Crossover Utility Vehicle (CUV) for \$17,000. This vehicle is needed to assist with off-road
14	searches as well as events held in the county where the use of on-road vehicles is not feasible; and
15	WHEREAS, such appropriation is necessary to provide funding for said expenditures.
16	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance for
17	Cecil County, Maryland for Fiscal Year 2023 is hereby amended for the supplemental appropriation in the
18	amount totaling \$417,000 from the County general fund balance to the Law Enforcement Department.
19	AND BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by the
20	County Council of Cecil County, Maryland.
