Allocate \$10,000,000 of Unassigned General Fund Balance
to a Committed Education Fund

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget
6 for Cecil County was adopted for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is requesting to allocate \$10,000,000 of the unassigned general fund
8 balance to the committed fund balance for the exclusive use of covering future mandated fiscal year
9 increases associated with the Maryland State Department of Education Maintenance of Effort and/or
10 Blueprint for Maryland’s Future; and

11 **WHEREAS**, this fund can only be used to address the Counties mandated expenses required to
12 operate Cecil County Public Schools.

13 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
14 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year
15 2024 is hereby amended to allocate \$10,000,000 of the unassigned fund balance to the committed fund
16 balance, as defined by Governmental Accounting Standards Board (GASB) Statement Number 54, to be
17 allocated for mandated expenses required to operate Cecil County Public Schools for future fiscal year
18 increases associated with the Maryland State Department of Education Maintenance of Effort and/or
19 Blueprint for Maryland’s Future.

20 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the
21 County Council of Cecil County, Maryland.
