Supplemental Appropriation – Grant Funds - Parks and Recreation –
Calvert Regional Park Basketball Court Improvements

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget
6 for Cecil County was approved for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is requesting that the Fiscal Year 2024 Special Revenue Other Grant
8 Funds - Parks and Recreation revenue estimate be revised in order to establish the following amount: the
9 addition of \$297,500 in grant revenue and expense to the Special Revenue Other Grant Funds – Parks and
10 Recreation budget to provide for the grant award from the Department of Natural Resources; and

11 **WHEREAS**, such appropriation is necessary to provide \$297,500 in grant funding for basketball court
12 improvements at the Calvert Regional Park.

13 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
14 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year
15 ending June 30, 2024 is hereby amended for the supplemental appropriation; and by amending the Budget
16 in order to appropriate \$297,500 in additional expenditures in the Special Revenue Other Grant Funds – Parks
17 and Recreation, to record the grant awarded from the Maryland Department of Natural Resources for the
18 purpose of improving the quality of Cecil County Parks and Recreation for the citizens of Cecil County.

19 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
20 Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
