Approval – Tasers with Accessories – Multiple Year Contract

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the County
6 Council adopted the budget for Fiscal Year 2024; and

7 **WHEREAS**, the Cecil County Sheriff’s Office budget for Fiscal Year 2024 includes \$55,278 for equipment
8 including, but not limited to, tasers; and

9 **WHEREAS**, the Cecil County Sheriff’s Office, by and through Cecil County Government, now desires to
10 enter into a five (5) year contract with Axon Enterprise, Inc. for the acquisition of sixty-five (65) Taser 10 Inert
11 Magazine Red with two spares, Inert Unitary Cartridge, Taser 10 Blackhawk Holster RH, Enhanced Hook-and-
12 Loop Training (halt) Suit V2, Target Frame Professional 27.5 in X 75 in, Certification Bundle. Included in the
13 bundle are all training cartridges, unlimited duty cartridges, and instructor training vouchers; and

14 **WHEREAS**, such acquisition is in excess of \$20,000 and is for multiple fiscal years and, as such, requires
15 County Council approval in accordance with Section 515(d) of the Cecil County Charter; and

16 **WHEREAS**, the County Executive now seeks County Council approval of the aforementioned five (5) year
17 contract with Axon Enterprise, Inc.

18 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
19 that the County Executive is authorized to enter into a five (5) year contract with Axon Enterprise, Inc. for the
20 acquisition of sixty-five (65) Taser 10 Inert Magazine Red with two spares, Inert Unitary Cartridge Blackhawk
21 Holster RH, Enhanced Hook-and-Loop Training (halt) Suit V2, Target Frame Professional 27.5 in X 75 in,
22 Certification Bundle. The bundle includes all training cartridges, unlimited duty cartridges, and instructor
23 training vouchers.

25 Resolution shall take effect on the date of its passage.
