Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, Department of Community Services, Housing and Community Development Division, Fund 111, Department 534 for the fiscal year ending June 30, 2024, in order to provide a total of \$775,000 to the Emergency Shelter Grants Fund; to record the grant awarded from the Maryland Community Development Block Grant program through the Maryland Department of Housing and Community Development to support the Holloway Beach Sewer Project and the Habitat for Humanity Home Rehabilitation Project.

Supplemental Appropriation – Grant Funds – Community Services – Community Development Block Grant – Holloway Beach Sewer Project – Habitat for Humanity Home Rehabilitation Project

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held public
4 hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the Budget
6 for Cecil County was adopted for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Emergency Shelter Grants fund revenue
8 estimate for Cecil County to establish the following amount: the addition of \$775,000 in grant revenue and
9 expense to the Department of Community Services, Housing and Community Development Division, Emergency
10 Shelter Grants Fund budget, Fund 111, Department 534, to provide for the grant from the Maryland Department
11 of Housing and Community Development Block Grant program; and

12 **WHEREAS**, such appropriation is necessary to provide \$775,000 in Community Development Block
13 funding to support the Holloway Beach Sewer Project and the Habitat for Humanity Home Rehabilitation Project;
14 and

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
16 that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2024 is hereby
17 amended for the supplemental appropriation; and by amending the current budget to appropriate \$775,000 to
18 the Emergency Shelter Grant Fund, Fund 111, Department 534, to record the grant awarded from Maryland
19 Department of Housing and Community Development, Community Development Block Grant funds, for the
20 purpose of supporting the Holloway Beach Sewer Project and the Habitat for Humanity Home Rehabilitation
21 Project.

22 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that this
23 Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
