Supplemental Appropriation – Grant Funds – Community Services
-Aging and Disabilities Division-State Senior Waitlist Grant

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2023, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2024; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2024; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 6, 2023, the
6 Budget for Cecil County was adopted for Fiscal Year 2024; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2024 Community Services Grants
8 Fund – Department of Community Services – Aging and Disabilities Division, Fund 109, Department
9 523, revenue estimate for Cecil County to establish the following amount: the addition of \$114,699 in
10 grant revenue and expense to the Community Services Grants Fund – Department of Community
11 Services budget to provide for a grant from the Maryland Department of Aging; and

12 **WHEREAS**, such appropriation is necessary to provide \$114,699 in grant funding to provide
13 staffing support and direct services to individuals currently on the Senior Care Program waiting list.

14 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
15 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
16 Year 2024 is hereby amended for the supplemental appropriation and by amending the Current Budget
17 to appropriate \$114,699 of additional expenditures in the Community Services Grants Fund –
18 Department of Community Services, Fund 109, Department 523, to record the grant awarded from the
19 Maryland Department of Aging.

20 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
21 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
22 Maryland.
